It is the competitor's responsibility to ensure they are free of skin lesions or allergies. • All entries must be completed on the Entry Form below and signed by a parent, or guardian, of the athlete. • Entry is open to all wrestlers who are members of a constituent Association of the Australian Wrestling Union Inc. • All athletes are required to present their Australian Wrestling Union "National Wrestling License" book to satisfy proof of age and membership. These books are available from the State Association. • "Junior" and "Senior" wrestlers are NOT eligible to enter this competition. • All competitors must make weight within the weight categories specified. There is NO weight allowance allowed.
